



By using this online reservation system or this written contract as provided by Zee Live Promotions and Marketing dba OrlandoLimoFinder.com you agree and consent to the following terms and conditions of use for the services provided by Zee Live Promotions and Marketing dba OrlandoLimoFinder.com. These same terms and conditions of service will also extend to any other Limo Finder Network services provided in the Continental United States. This includes the New Jersey Limo Finder Network and New York Limo Finder Network. Orlando Limo Finder Network services extend to Tampa, Jacksonville, West Palm Beach, Miami, and Fort Lauderdale Florida Limo Finder Networks provided by Zee Live Promotions and Marketing.

I understand that the credit card holder will be held responsible for any and all aspects of the limousine reservation. I understand and agree that this is a legally binding contract for services between myself and Zee Live Promotions and Marketing dba OrlandoLimoFinder.com.

I agree to have Zee Live Promotions and Marketing dba Orlando Limo Finder Network charge my credit card for the required Deposit Amount or Airport transfer fees of Limousine services based upon agreed Charter Rate or complete Airport Transfer Fee of your limousine rental. Deposits if needed are to be credited against the full fare.

I have read and agree that private/corporate aircraft pick up requests will be billed as a three hour minimum charter rate plus fuel surcharges of 10% of the fare and a 20% chauffeur gratuity is to be added to the bill. Private aircraft transfers returning for aircraft departure will be billed at the normal transfer rate unless the service requires additional driving or waiting time or is to and from airports not normally covered from Orlando and Sanford Florida.

I agree, Reservations made less than 24 hours before my pick up date and time must be verified by phone contact with one of our reservation agents at the time of the reservation by calling 407-436-8970. We reserve the right to refuse service with less than 24 hours notice. We cannot guarantee availability less than 24 hours in advance. No credits will be issued unless other arrangements have been made with our staff in advance.

I have read and understand the following: I Agree to abide by the cancellation policy and have read the cancellation and reservation policies completely.

Airport Transfers are paid in Full at the time of reservation and all charters require a deposit based upon the total of the first two hours of your Charter.

Deposits and Airport Transfer fees are not refundable but may be applied to rescheduled work within 30 days provided Orlando Limo Finder is notified seven days before the scheduled date of the service.

Failure to notify Orlando Limo Finder in writing of scheduling cancellations prior to seven days before the scheduled date of service will result in the forfeiture of your deposit and airport service fees. This includes prepaid gratuities. A full charge for the scheduled service that you requested will apply. Services reserved for holidays cannot be canceled without a full charge including gratuities. We will make every effort to work with you should an emergency arise. Changes to services if available, will be made where possible but are not guaranteed.

I agree to have Zee Live Promotions & Marketing DBA OrlandoLimoFinder.com charge my Credit Card for any damages to rented vehicle(s) caused by myself or any other person in my party. This includes clean up fees for vomit or excessive abuse of the interior/exterior of the vehicle caused by my party. I further agree not to allow any food product, i.e. potato chips, Doritos, or food of that sort to be consumed within the vehicle. Violation of this will constitute a cleaning fee starting at \$200.00.

Any passengers, who exhibit excessive alcohol abuse or possibly the use of an illegal substance, as determined by our Chauffeur, will constitute immediate termination of services. Client is responsible to reimburse Orlando Limo Finder affiliates for damages and downtime should the limousine be impounded due to client activities.

Vomit Cleanup fee's start at \$200.00 per man seat, this means the amount of seating space required for a person to sit up right in a limousine.

I also agree that any abuse of our Chauffeurs verbal or otherwise may terminate services on the spot without refunds. I agree to pay a full charge for the time used or unused plus a 20% gratuity will be added to the final bill if your ride is terminated by our Chauffeur for abuse of any kind or for any violation of this agreement.

I agree to pay no less than the minimum charge for my Limousine services Charters/Transfers as reserved by myself at the time of my reservation. I agree to be charged a additional 20% gratuity for a detailer or any other hired person to clean or repair damages from my party. This additional gratuity will be based on the dollar amount of the repair or cleaning service provided.

I have read and understand the following: No Shows will be billed in full minimum charter time or scheduled time, which ever is greater, plus 20% gratuity. After 20 minutes past the scheduled pick up time we may assume that our client has canceled without notice and depart the pick up location. In the case of an airport transfer Orlando Limo Finder will wait for 30 minutes past the arrival of scheduled airline service that the client has stated they are arriving on. To be considered a no show our Chauffeur or office must have had no contact with the client at the scheduled pick up time up in till the cut off grace periods described above.

I have read and agree and understand that should legal action become necessary I will be responsible for any and all legal fees that should arise in said collection efforts. I agree to waive my rights for the recovery of court costs and filing fees, taxes or other costs related to legal action and agree not to hold Orlando Limo Finder Network, Zee Live Promotions and Marketing or its affiliate operators liable for these fees. If I should prevail in a court of law I agree that these fees/court cost/process server cost should not be apart of any final judgment and I instruct the court not to include these fees in any final judgment. I further agree to pay for additional costs incurred for collections should my bill be turned over to a collection agency for any reason.

Additional charges may accrue for additional labor performed in the course of business to fix, repair or collect damages or funds not paid by myself. Unpaid bills will be subject to the maximum amount of interest allowed by law starting on the first day of unpaid services.

I further agree that if I should dispute any credit card charges and do not prevail, additional fees will be due to cover the additional expense of my dispute.

I have read and agree and understand that scheduled services that are delayed by our clients not being ready to depart on their scheduled times will be charged waiting time. We will wait for the first 15 minutes past the scheduled departure time free of charge. After the first 15 minutes has passed a charge of \$25.00 per 15 minute increments will be added to the cost of the transfer. The 15 minute charge will not be prorated by the minute. This policy is in place to help assure quality on time services to all our clients. The rule will not apply to charters by the hour. Last minute schedule changes will be met as availability requires.

Prom/Homecoming charters are non refundable and cannot be canceled under any conditions. A full charge plus driver gratuity will apply for any cancellations. Reservations made by minors using an adults credit card/ family member or other adult without the consent of the Credit Card holder will be criminally prosecuted to the fullest extent of the law for fraud. The credit card holder will be held liable for all charges and reservations. Card holder is considered negligent for not safe guarding the credit card holder's financial information from a minor or not reporting the Credit Card stolen. Thus causing damages to the Orlando Limo Finder Network and its affiliates by removing for sale our vehicles for the time and dates of the reservations acquired online, or otherwise reserved.

All persons using our reservations system by phone or internet must be at least 18 years of age. Orlando Limo Finder Network reserves the right to change the terms and conditions of this agreement to protect itself from harm without notice verbally or otherwise. Failure to provide a Credit Card with enough available credit to charge the estimated final balances may result in forfeiture of your security deposit and cancellation of services. A credit line security hold will be

placed equal to the estimated amount required to complete services and secure any possible damages. This is not a charge prior to service. At the completion of services this security hold will be used to authorize any final amounts due against the client's credit card.

Charter and transfer services are available using 47 and 57 passenger busses. The use of these vehicles requires special terms and conditions aside or in addition to other terms presented in this agreement. Terms and conditions for the use of busses are subject to change with or without notice.

All reservations made for either transfers or charter work will require a 30 day cancellation notice in writing by the client. Deposits will be taken equal to 50% of the charter fare and 100% for Transfers 30 days in advance of services. Motor coach bus charters for 49 and 57 passenger coaches are not liable for additional fuel surcharges. Cancellations made less than 30 days in advance of service requested will be billed in full including driver gratuity.

Bus services requiring more than one coach for the same service must be reserved either by completing one reservation online then submitting additional written requests for additional busses. Or can be done by repeating the reservation on our web site one time for each bus required.

Faxed reservation can be accepted using our printable online reservation form.

Reservations made less than 30 days in advance cannot be canceled without a full charge. No credit will apply.

Reservations made for service during the Daytona 500 race, Feb 18/2007 Super Bowl Feb. 4th 2007, International Home Builders show dates Feb 7th to Feb 10th 2007, require 30 days cancellation notice or a Full Charge including Driver gratuity will be charged, no credits will be given. Proms and Homecomings may not be canceled without a Full charge regardless of the dates. No Credits will be given for canceled Prom or Homecoming Events. Driver Gratuity is billable for Proms and homecomings at 20% of the fare, and will be automatically added to the fare for these services. Gratuity will be charged for canceled Proms and Homecomings in full.

We reserve the right to refuse service at anytime without notice.

New Years Eve and New Years day services may not be canceled without a full charge including driver gratuity of 20% of the fare.

New 2007 special town car rates are base rates only. Additional charges not included are Tolls, Fuel Charges, administration fees, and Gratuity of 20% of the fare total. Special fares are valid to and from select tourist destinations and Orlando International airport only.

Special base rates may also be offered for additional vehicles such as Vans and Limousines. Services offered using special base rates are reduced in cost for our clients. No cancellations will be accepted in exchange for these special base rate offering to and from Orlando International Airport and select tourist destinations. Orlando Limo Finder Network reserves the right to charge full fare at anytime due to market changes and Holiday's or special events as we see fit.
